Bookstore Memories

Last month, President Ida Hagman shared her memories of working at a bookstore, prompting

Sheryl Mylan to share this wonderful memory of visiting Kroch's and Brentano's.

"When I was in high school, my best friend Jeanne and I would always end our weekly shopping trips in Oak Park with a stop at the Kroch's and Brentano's on Lake Street. The staff at the store kindly allowed two teenage girls to sit undisturbed on a pile of books for hours as we sampled works in the classics section. I started reading "The Miller's Tale" in *Canterbury Tales.*" I knew Chaucer's name, although I had never read any of his work until that fateful afternoon. My fourteen-year old mind was shocked that an acclaimed literary master would write such a ribald story. I stumbled over the Middle English, reading the bawdiest passages again and again trying to comprehend what I was reading, then pointing them out to my friend and asking if they meant what I thought they did. Meanwhile, Jeanne read passages from Dante's Inferno and we imagined who we'd send to various circles of hell. We also learned about more contemporary movements, and our worlds expanded as we read Ginsberg's Howl and the works of Lawrence Ferlinghetti, and dreamed about places like the City Lights Bookstore--all while sitting quietly and enraptured in the middle of the store, Our regular reading adventures at the School of Brentano's continued until we went off to college. I'll always remember this as a truly a magical place and memorable time in my life."
